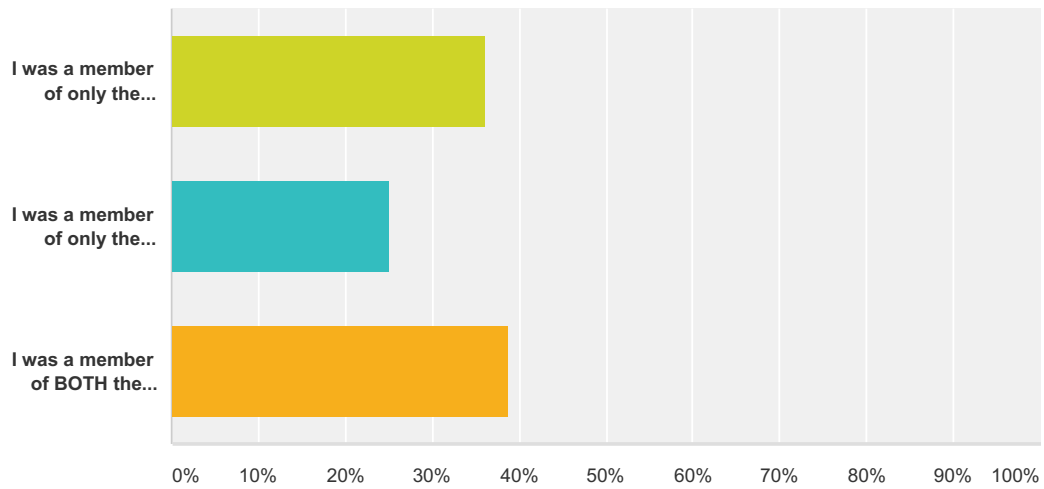


**Q1 At the time of merger (August 2014), I was a member of :**

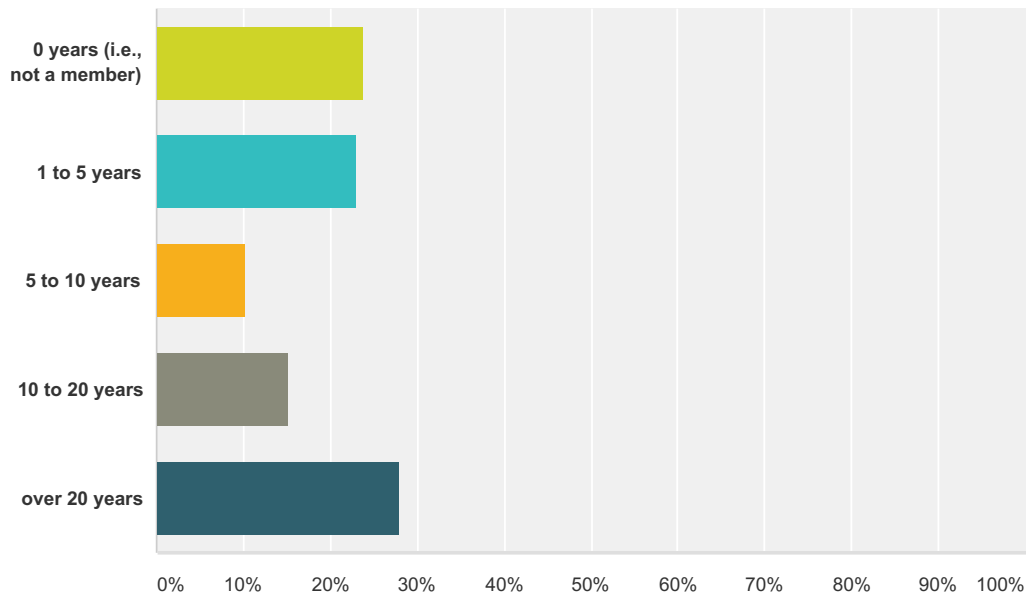

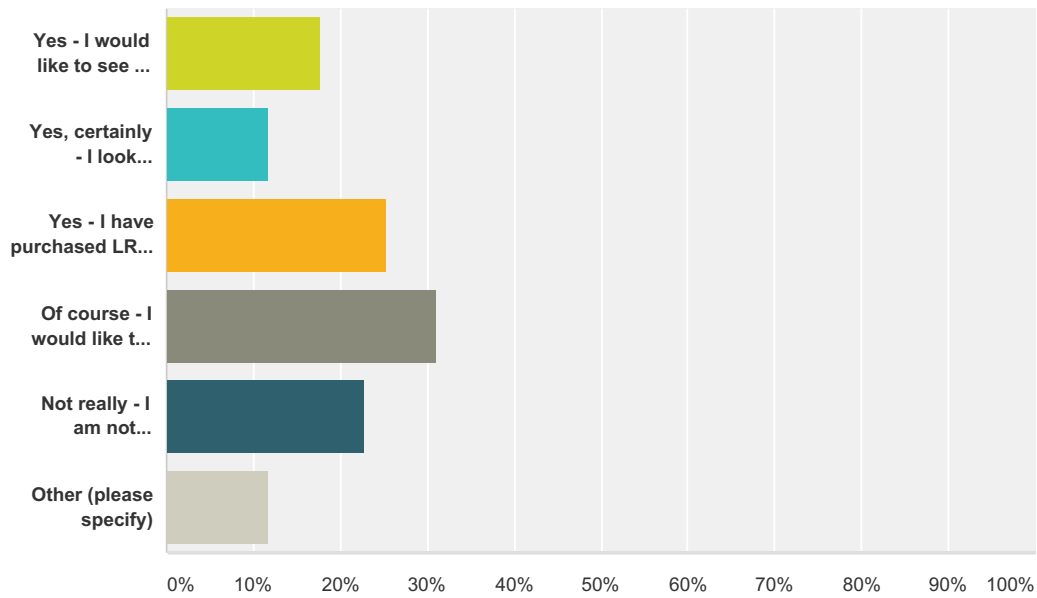
